



# Dragon Bus

## TRAVEL WAIVER

I understand and accept that whilst travelling with Dragon Bus may be a fantastic experience, it is not without risks, dangers, hazards and liabilities. I further understand that some of these risks, standards, laws of the Country I'm travelling in, facilities and expectations may be considerably different or non-existent in my own country and own experience. These include, but are not limited to:

- Personal injury, sickness or in severe cases - death
- Theft, vandalism or loss of personal property;
- Motor vehicle, rail or traffic accidents
- Unforeseen and/or extreme weather and environmental conditions
- Exposure to wildlife;
- The laws of the People's Republic of China, its Provinces and Territories;
- The medical facilities in the People's Republic of China, its Provinces and Territories,
- Criminal activity and crime rates that may pose a significant problem;
- Hazards resulting from political unrest, military and/or terrorist activity, previous or present; and
- Delays or cancellation of my Trip, or curtailment or cancellation of individual activities due to weather, flooding, illness, political disturbances, terrorism, motor vehicle accidents, transportation problems, failure to perform on the part of the travel agents, travel guides or airline companies, problems relating to customs, immigration or visa requirements, or other circumstances either within or beyond the control of Dragon Bus

I assume full responsibility for any risk, loss, damage or injury, including death, that may be sustained by me, or any loss or damage to property belonging to me, while travelling with Dragon Bus and hereby release, waive, discharge and release Three 6 Nine Group Pty Ltd trading as Dragon Bus (Dragon Bus), its directors, officers, servants, agents and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to this. I further hereby agree to indemnify and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur during my travels. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased.

I have read and understood the Dragon Bus trip notes for the trip I am undertaking and have provided details of any pre-existing medical conditions I have to Dragon Bus's representatives. If over 65, I may be required to provide a medical clearance from a registered medical practitioner prior to being allowed to travel. I confirm that I have a valid travel insurance policy which will cover me for any medical or other expenses while travelling with Dragon Bus and at no time expect Dragon Bus or their staff to cover any of these expenses on my behalf. In extreme circumstances and emergencies where this may occur, I agree to repay any and all costs to Dragon Bus prior to the end of my trip.

It is solely my responsibility to inform Dragon Bus and its staff of my whereabouts while part of my Dragon Bus trip, plus any changes to my chosen itinerary. I understand that Dragon Bus trips work on a set schedule and it is my responsibility to ensure that I am ready and in a fit state to travel at the appointed time, date and location of departure. In the situation where I am not available, I take full responsibility to arrange and pay for all costs to re-connect with the trip.

I accept these risks and obligations and I fully assume the risks of travel. I release Dragon Bus Travel from any liabilities connected to these risks to the maximum extent permitted by law of the Commonwealth of Australia, the Peoples Republic of China or any other Country to whom I have residence of."
